DEFINITION:

- x Prepares detailed routing instructions following plans provided by the supervisor.
- x Drives a school bus or transportation vehicle over an assigned route in accordance with a time schedule, as required.
- x Transports students, staff and chaperons on field trips, athletic activities and other special trips as needed.
- x Determine s appropriate action in emergency situations per established guidelines; administer s first aid to passengers as needed.
- x Transports other materials in District vehicles as assigned by the position.

LICENSES AND OTHER REQUIREMENTS:

- x Valid unrestricted State driver's license with appropriate passenger and air brake endorsements.
- x Valid School Bus driver's certificate.

- x Valid medical certificate approved by the Department of Motor Vehicles or Federal Highway Administration of the Department of Transportation and the ability to qualify for District insurance coverage.
