### 1. Call to Order; Roll Call; Recognition

Brian Daucher called the meeting to order at 6:32 p.m.

Bill Rauch of VTD presented the 6/30/11 Audit of IUSD

Some highlights include:

- o Page 2: Third paragraph: unqualified opinion, which is cleanest opinion given.
- o Page 62 no adjustment in the general fund, this is what management is looking for and the Board is looking at.
- o No material adjustments in the capital fund.
- o Page 63 gives trend in general fund.

2012 budget numbers and actuals from 2011 – 2009

Attendance in P-2

A lot of districts that VTD audits are not seeing increases in ADA, others are declining. IUSD has been increasing in attendance, this is great.

- o Page 76 Report Card no material weaknesses identified.
- o District received \$19+mil in federal awards.

Lots of federal testing, with no findings to report, this is good.

o Always going to have findings for ASBs.

Susana Lopez reported providing training for ASB accounting last week, and providing an Accounts Payable technician on a part-time basis to support the ASBs.

Some principals, athletic directors, admin. assistants, etc. attended the training.

Fiscal is looking at making this a mandatory training.

Annette suggested having the ASB treasurers also attend the training.

o Second finding – Stipends

Athletic stipends were not being run through the district; they were accounted for at each site.

Bill suggested taking measures to tighten controls over athletic stipends, and account for them through the HR department.

Susana added that the district has since corrected this, but the audit time period covered some time were this was still happening.

Bill added he anticipates the stipends findings will be removed from the audit report with the processes now in place.

## 4. Overview of Facilities Study Session Agenda, by John Fogarty

John announced there will be two Facilities Study Sessions, Jan. 31<sup>st</sup> and another in March, date yet to be determined.

Potential Middle school boundary changes,

- o Jeffrey Trail Middle School (JTMS) scheduled to open Sept. 2013
  - 1. The school boundary changes will impact Venado and Sierra Vista MS.
- o The recommended timeline for notifying parents of when JTMS will open and boundary changes is 24 months, IUSD is legally required to provide 15 months

# 5. Great West Lawsuit Update, by John Fogarty

The Trial court ruled a responsibility hearing needed to be conducted.

At the second responsibility hearing held, Dec. 17, Great West didn't provide the necessary documents requested.

o Great West's attorney claimed to not

- o District will still have to provide Spec. Ed transportation.
  - 1. Looking at \$1.1m cut.
- o Best case, Gov. gets initiative on ballot, it passes, but we are still looking at a transportation cut.
  - 1. Could be hard for the Governor to get support from the unions.

The Governor has said, if his ballot initiatives fail, education will be cut by \$4.8b.

First thing he will do is restore deferral for a net of \$2.4b.

\$370 per ADA or \$10.4 million cut to IUSD, if not passed.

o For a total of \$11.5m including transportation cut.

IUSD put aside \$7m this year in trigger cuts, we will be cut about \$1.5m this year and the remaining transportation funding for this year.

- o There is legislation to change the transportation cut this year to a per ADA cut.
  - 1. That would change our \$1m transportation cut to a \$1.5m cut.

IUSD should be left with about \$15m in reserve this year, to help with next year. Next year we are estimating a \$25m cut, for a net hole of \$10m.

Last year the ADA cut was a onetime cut, the current discussion is of an ongoing ADA cut. If this happens many other districts will not be able to survive.

We don't have enough information on the elimination of the RDAs, yet. Our fair share is about \$15m.
