- Assess and evaluate the health and devlopmental status of selected students through nursing diagnosis and the use of appropriate evaluative techniques.
- Work cooperatively with other School Assessment Team members to assess **but**h needs related to learning, and determine appropriate educational plan.
- Complete Health and Developmental History and 3 yearupdates as needed.
- Conduct (or arrange for) mandated vision and hearing screening.
- Conduct mandated Scoliosis Screening requireseam approach.

QUALIFICATIONS GUIDE

CREDENTIAL:

- Valid California registered nurse license and credential authorizing health services in grade level K12.
- Must possess or be willing to obtain, American HearAssociation BLS Instructor's Certification, and Medic First Aid Instructor's Certification.

EDUCATION:

Bachelor's degree, including all courses to meet credential requirements.

EXPERIENCE:

Clinical nursing experience and/or previous school nurse experienceTeaching experience desired.

PERSONAL QUALITIES:

- Appearance, grooming and personality which establish a desirable example for students.
- Ability to meet district standards for physical and mental health. Above average recommendations
 from supervisors and other professionals who have observed the characteristics, scholastic
 attainment and performance of the nurse.

PHYSICAL DEMANDS:

- While performing the duties of this job, the employee is regularly required to use hands to finger, handle, or feel objects, tools, or controls and talk or hear.

- The employee must occasionally lift and/or move up to 25 pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust focus.

WORK ENVIRONMENT:

The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Reasonable accommodations may breade to enable individuals with disabilities to perform the essential functions. While performing the duties of this job, the employee is frequently exposed to times or airborne particles. The employee occasionally works in outside weather conditions and is occasionally exposed toxic or caustic chemicals. The noise level in the work environment is usually moderate.
