

LICENSED VOCATIONAL NURSE

DEFINITION:

Under the supervision of a Credentialed School Nrse, this classified employee provides health services for students in special education programs and general education settings within limits of licensure; administers medications and performs other specialized physical health care procedures in accordance with physician's orders; and performs related duties as assigned.

ESSENTIAL DUTIES AND RESPONSIBILITIES lude the following. Other duties may be assigned.

- Under the direction of a School Nurse and currentmedical orders, performs a variety ofspecialized
 medical health care duties, including but not limited to: administering medication orally or through a
 g-tube; administering g-tube feedings; suctioning trachea and/or nose and mouth; performing
 urinary catheterizations.
- Monitors the physical and medical conditions of assigned students and communicates with school
 nurse, staff and parents as appropriate regarding any school site medical problems or in the exteof
 any unusual activities or behavior.
- Provides toileting care as needed and assists in physically positioning and/or transferring and lifting students as required.
- Maintains procedural report logs and appropriately reports on assigned student's condition through proper documentation.
- Assists assigned student with classroom tasks as appropriate.
- Submits monthly LEA billing.

QUALIFICATIONS GUIDE

Knowledge of:

- Needs of medically fragile students.
- Correct medical procedures for specialized health needs
- Motivational techniques for students.
- General goals of special education in the public schools.
- Record keepingtechniques.
- Confidentiality laws relating to student records.
- Emergency medical treatment and first aid.
- Community health resources.
- Correct English usage, grammar, spelling, punctuation, and vocabulary.
- Interpersonal skills involving tact, patience, and courtesy

Ability to:

- Perform specialized health procedures.
- Communicate clearly and effectively verbally and in writing.
- Supervise students.
- Lift and move students safely.
- Push and pull wheelchair.
- Dispense medication according to physician's orders.
- Understand and carry out written and oral directions/instructions.
- Maintain cooperative relationships with co-workers.

EDUCATION/EXPERIENCE:

Any combination equivalent to: graduation from high school; completion of an accredited program for

vocational nurses; one year of experience in nursing or working with children in a medical setting.

LICENSES AND OTHER REQUIREMENTS:

- Possession of a validCalifornia driver's license.
- Possession of a valid California license in vocational nursing.
- Possession of a valid and current first aid and CPR certificate.

PHYSICAL DEMANDS:

The physical demands described here are representative of those that must be they an employee to successfully perform the essential functions of this job. Reasonable accommodations may be the individuals with disabilities to perform the essential functions.

- Sitting and standing for extended periods of time.
- Dexterity of hands and fingers to operate a computer keyboard.
- Hearing and speaking to exchange information in person or on the telephone.
- Reaching overhead, horizontally and above shoulders.
- Bending the waist, kneeling or crouching.
- Lifting, carrying, pushing and pulling up to 25 lbs.
- Seeing to read a variety of materials.
