Adoption of the Agenda

On the motion of Member Kuwabara, seconded by Member Parham and carried 5-0, the Board adopted the agenda as presented.

District Goals and Future Planning Workshop

The Board met with Executive Cabinet members in a workshop setting to discuss district goals and future planning.

Board president Huntley-Fenner welcomed those present and expressed appreciation for the opportunity to brainstorm and dialogue about our future and what we envision for our students.

Superintendent Gross summarized the process and anticipated outcomes for the meeting and presented the "Broken String" metaphor.

Assistant Superintendent Walker reviewed the tenets of the interest-based planning process to be followed for the meeting.

The Board reviewed the District's Vision Statement and determined no significant changes were needed.

Assistant Superintendent Cassie Parham summarized the 2009-10 Continuous Improvement Efforts, reviewed by the Curriculum Council on an annual basis, which were determined to be comprehensive, fluid and current. Parham discussed the District's focus on developing Professional Learning Communities and remarked on the positive impacts and outcomes as a result of that effort.
